Subject: Collaboration with C-DAC/ISEA for Launch of Free Online Cybersecurity Awareness Courses for Students & Teachers- regarding

The Board is in receipt of letter dated 18.08.2025 from the Centre for Development of Advanced Computing (C-DAC), regarding its flagship project *Information Security Education and Awareness (ISEA)* under the Ministry of Electronics and Information Technology (MeitY), Government of India, which has been actively engaged in creating and disseminating cybersecurity awareness across the country. The initiative aims to strengthen the nation's digital immunity by reaching out to students, teachers, parents, professionals, and the general public.

As part of this initiative, two specially designed free online cybersecurity awareness courses are being launched for CBSE students and teachers:

1. **Cyber Kid** – An interactive course for students of Classes 5 to 8 (and other interested learners), covering cyber ethics, online safety, cyber hygiene, cyberbullying, safe downloads, device/browser security, and responsible online behavior. The course is self-paced, uses engaging animated videos, cartoon stories, and quizzes, and provides instant certification upon completion.
2. **Cyber Shikshak** – A dedicated program for educators to enhance their knowledge of cyber hygiene practices, secure use of digital learning platforms, online fraud awareness, safe mobile app usage, device security, and cybersecurity career pathways. This course is also self-paced, easy to follow, and offers **instant certification**.

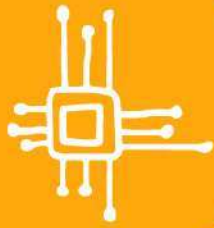
